I am aware of the risks of participating in the Chuck's Run as a virtual participant - and assume all such risks.

By indicating your **acceptance**, you <u>understand</u>, <u>agree</u>, <u>warrant</u> and <u>covenant</u> as follows:

In CONSIDERATION of your accepting my entry, I, intending to be legally bound, do hereby, for myself, my heirs, executors, and administrators, forever waive, release and give up any and all claims, demands, liability, damages, costs and expenses of any kind whatsoever, including personal injuries to me or wrongful death against **Dystonia Medical Research Foundation Canada (DMRFC), Chuck's Run;** All other associations, all sanctioning bodies, all sponsoring corporations and all of their respective directors, employees, officials, servants, successors, recreation and parks department, sponsors, volunteers, contractors, subcontractors and their employees, representatives, agents and heirs, which may arise from my participation in the **Chuck's Run, May 31 to June 30, 2020.** I FULLY UNDERSTAND I AM FOREVER GIVING UP IN ADVANCE ANY RIGHT TO SUE OR MAKE ANY CLAIM AGAINST THE ABOVE MENTIONED PARTIES I AM RELEASING IF I SUFFER SUCH INJURIES AND DAMAGES EVEN THOUGH I DO NOT KNOW WHAT OR HOW EXTENSIVE THOSE INJURIES AND DAMAGES MIGHT BE AND AM VOLUNTARILY ASSUMING THE RISK OF SUCH INJURIES AND DAMAGES.

I am aware that participating in an event that is organized as a virtual activity where I run/walk/wheel on my own, at a date and time of my choosing, in a location and route of my choosing, which will not have any support or security measures in place by DMRFC is a potentially hazardous activity, which could result in injury or death. I acknowledge that I am participating in the activity outlined by this virtual event by my own free will and at my own personal risk. Ι attest that if my community has a shelter in place order, that I will only participate in the virtual event independently and indoors and I will not run/walk/wheel outside in the community during the duration of a shelter in place order. I agree to follow all pedestrian safety ordinances including running/walking/wheeling on a sidewalk where available and not in the road. I agree to follow the rules of the road if no sidewalk or multi-use trail is available and I will run/walk/wheel against oncoming traffic and not with traffic.

I further agree to hold harmless and indemnify the above mentioned parties from and against any and all liabilities which any of them may incur as a result of, or in any way connected with, my participation in Chuck's Run by the dangerous or defective condition of any product, merchandise, prizes or equipment owned, maintained, distributed or controlled by them and/or because of their liability without fault.

I agree to abide by any decision of a race official relative to any aspect of my participation in this virtual event, including the right of any official to deny or suspend my participation for any reason whatsoever. I attest that I having read the rules of the virtual run/walk/wheel scheduled for **May 31** to **June 30**, **2020** including the terms in this waiver, the timeline of the virtual event, and agree to abide by them. I assume all risks to me associated with running/walking/wheeling on my own as part of this virtual activity, including but not limited to: falls, contact with other pedestrians, the effects of

the weather, including high heat and/or humidity, traffic and the conditions of the road or trail, all such risks being known or unknown and appreciated by me when out running/walking/wheeling on my own without any type of support from local officials or event organizers.

I certify that I am at least 18 years of age and in the event that I am registering a child under the age of 18, I confirm that I am the parent or legal guardian of that party and have the legal authority to enter this agreement on their behalf. I attest that I am <u>physically able to participate in this event.</u> I will assume my own medical and emergency expenses in the event of an accident or other incapacity or injury resulting from or during my participation in Chuck's Run and agree to not hold DMRFC and the related parties outlined above responsible for any costs associated with such treatment. In consideration of this being an amateur event, <u>I release the rights of any and all photographic material</u>, <u>motion picture</u>, <u>video tape</u>, <u>recordings</u>, <u>advertisement (print, broadcast, or online) and/or computer information organizers may wish to release for this event without further notice or compensation to <u>me</u>.</u>

RACE ROSTER REGISTRATION AGREEMENT AND LIABILITY WAIVER (the "Agreement and Waiver")

1. Authority to Register and/or to Act as Agent.

You represent and warrant to DMRFC and Race Roster-a subsidiary of Fast North Corp.
