



Dystonia Medical Research Foundation Canada (DMRFC) Volunteer Waiver

I AGREE that throughout the **Dystonia GTHA Patient Support Health Fair: 50 Years of Community (the "Event")**, hosted by the **Greater Toronto Area Dystonia Support Group ("GTA SG")** in partnership with **Dystonia Medical Research Foundation Canada ("DMRF Canada")**, taking place on October 25th, 2026, at **BMO Education & Conference Centre** in Toronto, Canada, my safety remains my sole responsibility at all times. I am aware of the risks of volunteering in the Event, assume all such risks, and therefore release the GTA SG and DMRF Canada from any liability arising from my involvement as a volunteer at the Event.

IN CONSIDERATION of accepting my application to volunteer at the Event, I know and accept all the risks that may arise in volunteering at an organized event. I know that I must be medically able and fit to volunteer and agree by signing this waiver that I am fit and able to partake in the day's activities and fulfill my volunteer responsibilities. Knowing these facts I, for myself, my heirs, executors, administrators, and legal representatives, HEREBY RELEASE, WAIVE, FOREVER DISCHARGE and agree to hold the GTA SG, DMRF Canada and all other associations, all sanctioning bodies, all sponsoring corporations and all of their respective directors, employees, volunteers, agents, officials, servants, representatives and successors of and from all claims, demands, costs, expenses, actions and causes of action, whether in law or equity, in respect of any death, injury, loss or damage to my person or property (a "LOSS") HOWSOEVER CAUSED arising or to arise by reason of my participation in the Event whether as a volunteer, spectator, participant, employee or otherwise, whether the Loss occurs prior to, during, subsequent to the Event or while travelling to or from the Event, even if caused in whole or in part by the negligence or other fault of the parties or person or persons. I FURTHER AGREE to hold harmless and indemnify the parties from and against any and all liabilities which any of them may incur as a result of, or in any way connected with, my participation in the Event by the dangerous or defective condition of any property or equipment owned, maintained or controlled by them and/or because of their liability without fault. I UNDERSTAND THAT EVENTS MAY BE HELD OVER PUBLIC ROADS AND FACILITIES OPEN TO THE PUBLIC DURING THE EVENT AND UPON WHICH HAZARDS ARE TO BE EXPECTED. I, consent to being provided emergency treatment in the event of illness or injury during my participation in the Event and agree to not hold the GTA SG, DMRF Canada and the related parties outlined above responsible for any costs associated with such treatment.

I also understand that this is a public event held in a public venue. Photos will be taken throughout the Event, and I give consent to my photo being taken and being used in conjunction with publicity surrounding the Event. I also consent to the publication and/or other use of my name, voice, electronic or video image, motion picture, video tape, recordings, computer information or other likeness without further notice or compensation to me, in any publicity or advertisement carried out by the GTA SG and DMRF Canada in any manner whatsoever, including print, broadcast, or online.

the GTA SG and DMRF Canada may publish the photos and results of the Event online for promotion or other account of the Event. BY SIGNING BELOW, I ACKNOWLEDGE HAVING READ, UNDERSTOOD, AND AGREED TO THE ABOVE WAIVER, RELEASE, INDEMNITY, AND I WARRANT that I am sufficiently trained to safely volunteer in the Event.
