

Write a letter to the Minister of Health and Long-Term Care

1. Write a letter to the Minister of Health

- Use the template provided:
The file is in PDF. You will have to cut and paste into a Word file or contact info@dystoniacanada.org to have the letter sent to you in Word file
- You need to complete all sections that are written in *ITALICS*
 - i. Fill out your contact information at the top (i.e. name, mailing address)
 - ii. Write your personal story
 - iii. End the letter with your signature and name
